Rosseti intends to merge LOESK with Lenenergo, they are already negotiating this

The head of PJSC Rosseti, Andrey Ryumin, sent a letter to President Vladimir Putin on the consolidation of the power grid in the Leningrad region. According to the resource 47news, which has a document in circulation, Ryumin proposes to merge the energy company JSC LOESK into Rosseti Lenenergo PJSC "by acquiring a stake in LOESK by Rosseti Lenenergo in the amount of at least 75% + 1 share."



The Kalugaenergo branch connects new cellular communication stations

As part of the program to eliminate the digital divide, since the beginning of the year, the Kalugaenergo branch has provided power to 26 communication facilities in settlements of the Borovsky, Maloyaroslavetsky, Khvastovichsky, Lyudinovsky, Zhukovsky, Kirovsky, Tarussky Peremyshlsky, Meshchovsky districts of the region and on 11 streets of Kaluga, the Informationbureau telegram channel reports. 270 kW of additional power has been allocated to new infrastructure facilities, which contributes to the effective development of voice communications and mobile Internet, including in small populated areas.
