This cost can be paid by one of the parties to the transaction, or the parties can distribute the payment among themselves.

In case of transfer of property rights as a result of inheritance by several heirs, the service is paid for debiting the deceased account and crediting each heir to the account.

The cost of securities, provided for by points 6, 7 and 8 of the Price-list, is determined based on the number of securities debited from the personal account and the market price of the security, determined in the manner established for determining the tax base for personal income tax in accordance with Chapter 23 of the Tax Code of the Russian Federation on the date preceding the date of submission of documents to the registrar, and if the specified market price is not determined – the cost of the securities is determined as the product of the nominal value of the specified securities by their number.
