## ITEM NO. 6 «ON APPOINTMENT OF THE AUDIT ORGANIZATION OF ROSSETI CENTRE, PJSC»

**Explanatory information on the item (information about the candidacy of the audit organization, including information on the self-regulatory organization of auditors of which the candidate for the audit organization is a member, information about the procedures used in selecting the audit organization, which ensure its independence and objectivity, information on the proposed remuneration of the audit organization for audit and non-audit services, as well as information on other material terms and conditions of an agreement concluded with the audit organization)**

In accordance with Federal Law dated 26.12.1995 № 208-FZ "On Joint-Stock Companies", the agenda of the annual meeting of the General Meeting of Shareholders of the Company should include the issue of appointing the Company's audit organization.

Federal Law dated 26.12.1995 № 208-FZ "On Joint-Stock Companies" does not specify the term and procedure for nominating an audit organization to be included in the voting list on the issue of appointing the Company's audit organization. The Federal Law does not give shareholders the right to nominate an audit organization either.

In this regard, the audit organization for appointment at the annual meeting of the General Meeting of Shareholders of the Company shall be determined by the Board of Directors of the Company within the framework of the preparation of holding the annual meeting of the General Meeting of Shareholders of the Company.

The conditions for conducting procurement procedures for selecting an external auditor for the right to conclude an agreement to conduct a mandatory annual audit of RAS statements and an audit of IFRS statements of Rosseti Centre, PJSC for 2024 - 2026 were preliminary reviewed by the Audit Committee of the Board of Directors of the Company on 29 January 2024 (Minutes No. 02/24), according to which the initial (maximum) purchase price is determined in the amount of 27,720,000.00 rubles, including VAT.

PJSC Rosseti on the basis of the order received from Rosseti Centre, PJSC conducted a centralized electronic tender on a single electronic trading platform ([www.rosseti.roseltorg.ru](http://www.rosseti.roseltorg.ru)) for the right to enter into an agreement for the provision of services for conducting a mandatory annual audit of RAS statements and an audit of IFRS statements of subsidiaries of PJSC Rosseti for 2024-2026 (including for Rosseti Centre, PJSC). According to the results of the Tender, the Association of Auditors (the collective participant) consisting of the leader of the collective participant B1 - Audit LLC and the member of the collective participant Intercom-Audit LLC was recognized as the Successful Bidder (Minutes of the meeting of the Tender Commission dated 14.03.2024 № 4/2977634), the proposal of which was recognized as the best.

**B1 - Audit LLC** (until 14 January 2026 - TSATR - Audit Services LLC, earlier until 12 April 2022 Ernst & Young LLC) has been operating in the market of audit and consulting services in Russia since 2002. B1 - Audit LLC is a member of the Self-Regulatory Organization of Auditors Association "Sodruzhestvo" (SRO AAS) and is included in the register of auditors and audit organizations of SRO AAS under main registration number 12006020327. B1 - Audit LLC has significant experience in providing audit and audit-related services to the largest public and private Russian companies. The B1 Group of Companies offers a full range of professional services, including services in the field of audit, strategic, technology and business consulting, transactions, taxation, law and business support, in Russia and Belarus. B1 - Audit LLC currently has around 1,900 employees. The professional liability of B1 - Audit LLC is insured by JSC AlfaStrakhovanie. The insured amount (aggregate) for all insured events is 3,000,000,100 (Three billion one hundred) rubles. Based on the results of its activities for 2024, B1 - Audit LLC is included in the List of the largest Russian audit organizations (entities engaged in auditing activities), compiled by the RAEX rating group, and ranks 2nd in it.

**Intercom-Audit LLC** has been operating in the market of audit and consulting services in Russia since 1994. Intercom-Audit LLC is a member of the Self-Regulatory Organization of Auditors Association "Sodruzhestvo" (SRO AAS) and is included in the register of auditors and audit organizations of SRO AAS under main registration number 11606074492. Intercom-Audit LLC is a team of professionals with deep knowledge and diverse experience in financial and industrial structures in Russia and abroad. Intercom-Audit LLC employs 130 auditors, holding qualification certificates and being members of the SRO. The professional liability of Intercom-Audit LLC is insured by JSC AlfaStrakhovanie with a liability limit of 5,000,100,000 (Five billion one hundred thousand) rubles.

B1 - Audit LLC and Intercom-Audit LLC fully comply with the requirements of Article 8 "Independence of Auditing Organizations, Auditors" of Federal Law No. 307-FZ of 30 December 2008 "On Auditing Activities" and the Rules for the Independence of Auditors and Auditing Organizations.

The Audit Committee on 12.05.2026 (Minutes No. 09/26) recognized the association of auditors as part of B1 - Audit LLC and Intercom-Audit LLC to comply with the principles of independence, objectivity and recognized the absence of a conflict of interest between the association of auditors and the Company.

The Board of Directors on 13.05.2026 (Minutes of 14.05.2026 No. 14/26) adopted the recommendations of the Audit Committee to recommend that the General Meeting of Shareholders of the Company to appoint the collective participant consisting of B1 - Audit LLC (the leader of the collective participant) and Intercom-Audit LLC (the member of the collective participant) as the audit organization of Rosseti Centre, PJSC for 2026 and at the same meeting determined the cost of the audit organization's services for 2026 in accordance with the recommendations of the Audit Committee issued on the basis of the procurement procedures.

The Agreement with the audit organization will enter into force after the appointment of the audit organization at the annual meeting of the General Meeting of Shareholders of the Company.
