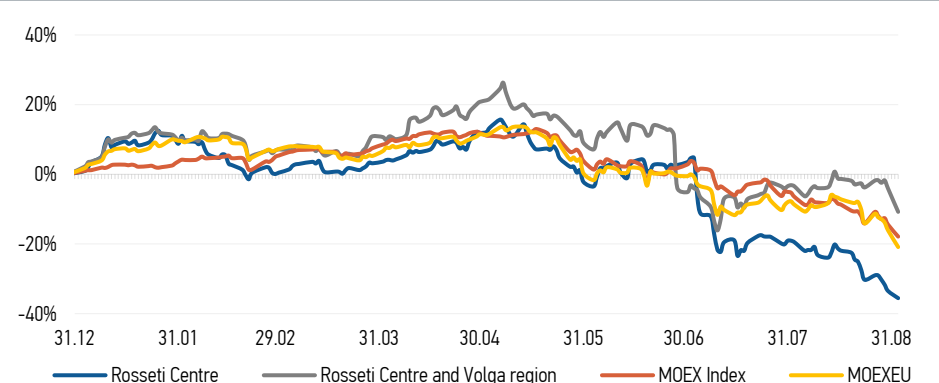

The "Power Engineers' Hotline "Light Line 220" of Rosseti Centre and Volga region, PJSC receives information from citizens about calls in which fraudsters, posing as employees of PJSC Rosseti, offer to replace electricity meters for free. To do this, the fraudsters ask to provide personal data. Rosseti Centre and Volga region, PJSC warns: be extremely careful when communicating with unknown telephone interlocutors. Remember that PJSC Rosseti's employees never request your personal data over the phone and do not offer to replace meters without official notification.
