The Energy Committee recommends that the State Duma adopt in the second reading bill N594962–8 on amending the Federal Law "On the Electric Power Industry" and certain legislative acts of the Russian Federation (on backbone territorial grid organizations (BTGO) and the introduction of automatic remote control of operating modes of electric power industry facilities), Deputy Chairman of the Committee Yury Stankevich said in his telegram channel.


