



The core business of Rosseti Centre is electric energy transmission and grid connection of new customers. The Company also develops additional non-tariff services. The Company controls 91% of the electric energy transmission market and 93% of the grid connection market. Rosseti Centre is one of the leaders among public distribution grid companies in terms of revenue.
