Selection of new generation for the south of Russia in the amount of 855–941 MW should take place before 16 August

The Government of the Russian Federation ordered a competitive selection of new generation capacity for the Unified Energy System of the South until 16 August; the corresponding order appeared on 5 July on the portal of the official publication of legal acts.

Generating facilities, according to the document, must be located "on the territory of the receiving part of the energy system of the Republic of Adygea and the Krasnodar Territory in the Central Kuban energy district." The capacity of the constructed facilities shall be 855–941 MW, commissioning dates are scheduled for 1 July 2029. Moreover, the power of each power unit within the station can vary from 25 to 470 MW.


