The head of the State Council's Energy Committee, Aysen Nikolayev, stated the need to transfer the functions of the System Operator to Rosseti starting in 2028

The full transfer of the functions of the System Operator to Rosseti starting in 2028 is necessary to accelerate the development of the Russian grid facilities. This was announced to journalists by Aysen Nikolayev, the Chairman of the State Council's Energy Committee and Head of the Republic of Sakha (Yakutia). Nikolayev emphasized that the depreciation of grid companies' equipment in some regions reaches 85%



Rosseti Centre and Volga region completed nearly 3,800 contracts for new connections to power grids in the Tula region

For 9 months of this year, the branch of Rosseti Centre and Volga region – Tulenergo completed 3,781 contracts for new connections to power grids with a total capacity of 95.6 MW. The majority of the connections were made to the preferential category of consumers with a capacity of up to 15 kW. 3,491 such facilities with a total capacity of 44.8 MW were connected to the grid.
