### Departments found consensus on differentiation of FGC tariffs, continue to discuss terms

The Federal Antimonopoly Service (FAS) of Russia and the Ministry of Energy agreed on their positions on the FGC UES tariff differentiation project, but the question of the timing of bringing the grid tariff in the backbone grids to the tariff for transmission in lower voltage grids has not yet been resolved, said on Tuesday, 6 September, to reporters Head of the FAS Russia Igor Artemiev.

The branch "Rosseti Centre Tverenergo" continues to implement a set of measures to combat electricity theft.


