A new Digital Transformation Strategy of the Rosseti Group adopted

The Board of Directors of PJSC Rosseti approved the Digital Transformation Strategy. The document, which takes into account the methodological recommendations of the Ministry of Digital Development of the Russian Federation, is designed for 2024-2027 and contains forecast indicators until 2030. The document provides for the implementation of initiatives to introduce artificial intelligence in accordance with the instructions of the President of Russia. The most promising areas for this include searching for and preventing equipment malfunctions, forecasting grid loads, automating customer services, and reducing losses.


