#### New tax benefits for electric power facilities will be introduced from 2025

Russian President Vladimir Putin signed Federal Law No. 362-FZ of 29 October 2024, establishing a number of tax benefits for electric power facilities. The document was published on the Official Internet Portal of Legal Information. The Federal Law creates “additional economic conditions that stimulate the modernization of fixed assets related to electric power facilities of organizations, as well as ensuring a unified methodological approach to the taxation of a number of electric grid facilities,” as explained in the information letter of the Federal Tax Service of the Russian Federation.

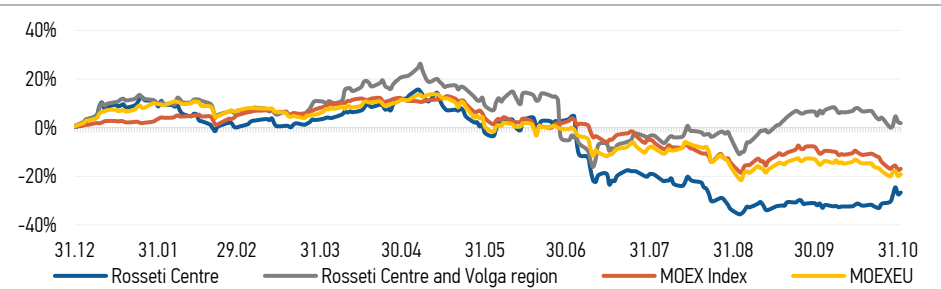
