The Rosseti Group Human Rights Policy has been approved

The decision was made by the Board of Directors of PJSC Rosseti. The document is fundamental and applies to relationships with employees, consumers, partners and other stakeholders at all levels of operational activities. The key provisions of the Policy include non-discrimination, equal opportunities, ensuring safe and favourable working conditions, respect for cultural characteristics, freedom of assembly and association. A separate Human Rights Policy has been developed for the first time.

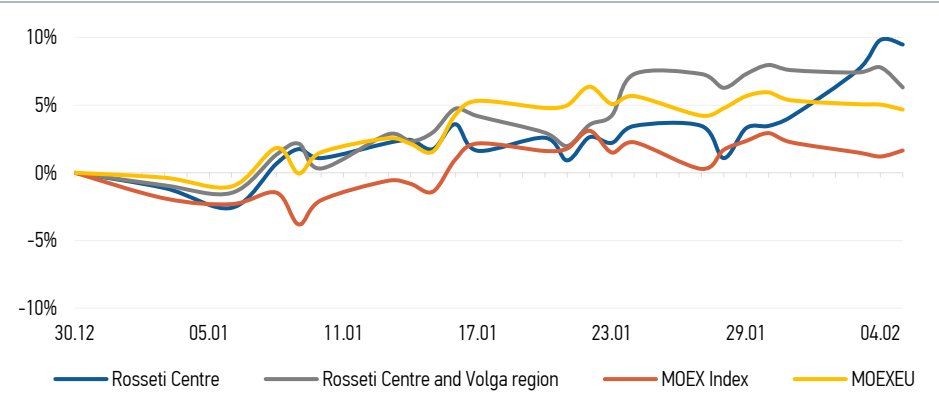
