Tverenergo’s specialists continue to restore power supply in the Tver region after a snow cyclone

Power engineers from Yarenergo, Kostromaenergo, Ivenergo, Vladimirenergo, Ryazanenergo, Tambovenergo, Nizhnovenergo, Rosseti Lenenergo, Rosseti Moscow Region are helping to restore power supply in the Tver region. Together with Tverenergo’s employees, 155 crews are working today to eliminate damage to power lines after the snow cyclone: 549 people, 227 special vehicles have been involved.

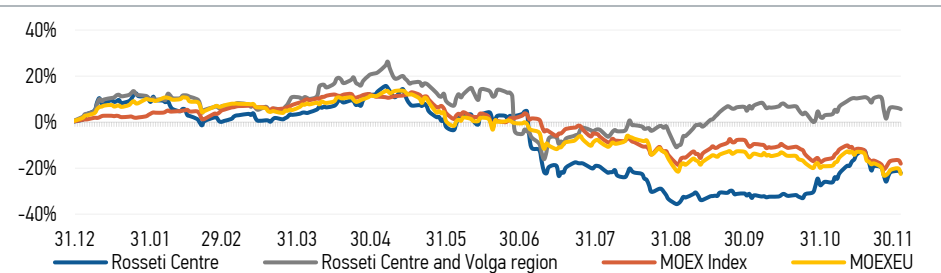
