Russian President Vladimir Putin ordered to sign an agreement on the creation of a unified energy market of the Union State, the corresponding document was published on Monday on the official portal of legal acts of the Russian Federation.

“Accept the proposal of the Government of the Russian Federation to sign an agreement between the Russian Federation and the Republic of Belarus on the formation of a unified market for electric energy of the Union State,” the order states.

Achieving one of the Company's strategic goals - reducing electricity losses - requires both competent technical solutions and the use of modern innovative equipment.


