One on one with the Baikal-Amur Mainline

OJSC Russian Railways has no one to share RUB 40 bln payment for connection to grids.

The updated forecast for the cost of electrification of the eastern Baikal-Amur Mainline for OJSC Russian Railways amounted to RUB 220 bln, the calculation included the increased planned costs for technical connection. Instead of RUB 6–7 bln for it, OJSC Russian Railways will spend RUB 40 bln, since other potential industrial consumers in the region, with whom the monopoly could share costs, have frozen their projects. Electrification is economically justified, at least because Russian Railways can save RUB 40 bln per year on the purchase of diesel fuel, experts indicate.


